- A designated area will be provided for all vendors. **The vendor must provide all the necessary licenses, equipment, heating and cooking apparatus, chairs, tables, and tents for each space.**
- Vendors are solely responsible for all financial transactions connected with his/ her merchandise. Please be prepared to provide change for your cash transactions. **LSBA and or our sponsors or partners will not be responsible for any damages, losses or thefts of merchandise or display equipment.**
- The Long Street Tour is a family orientated event. Only the sale of quality merchandise will be permitted under this contract. **The sale of illegal, questionable, or distasteful items will not be permitted. In the event of a dispute, the decision of LSBA will be final and no refunds will be made.**
- We ask that each vendor demonstrate a professional demeanor while selling and displaying their items. Please keep in mind that this is a family oriented event. **No alcoholic beverages, drug paraphernalia, or weapons of any kind are to be brought in for sale.**
- A rental fee of \$150.00 for each vendor must be submitted with a signed copy of this agreement, no later than August 28, 2010. Reservation will be confirmed upon receipt of your signed agreement and payment. The confirmation information will include a rental receipt to post on your display table during the day of the event as well as Tour materials.
- **There will be no refunds if you fail to attend this event or cancel your registration.**
